# SCA Land Use and Transportation Committee Meeting Notes May 7, 2013, 4520 NE 19<sup>th</sup> Avenue

Attending: David Sweet, Randy Ward, Kirk Wolfe, Rachel Lee, Derrik Abram

**Prescott Pedestrian Safety:** Derrick Abram, who lives at 4532 NE 20<sup>th</sup> Avenue, attended to share his concerns about traffic on Prescott Street:

- With no traffic controls from 15<sup>th</sup> to 33<sup>rd</sup>, traffic speeds are too high.
- Cars do not stop for pedestrians at intersections.
- Off-set intersections from 15<sup>th</sup> to 20<sup>th</sup> are particularly difficult for pedestrians.
- 15<sup>th</sup> is a particularly dangerous intersection.

He believes that the 30 MPH speed limit should be lowered to 25, and to 20 around 15<sup>th</sup>. He thinks there should be a crosswalk and stop sign at 27<sup>th</sup> for the bus stop and the Food King Market at 29<sup>th</sup>.

The committee told Mr. Abram that we would pursue improved pedestrian safety on Prescott. Our experience is that when we ask the City for specific improvements they look only at those improvements and tell us that they are not warranted. We do better when we point to the problems and ask for improvement. David will contact PBOT in this regard. ## **Updates:**

- Green Streets—We have submitted our 90% drawings to the City, and expect the go-ahead soon to do construction this summer.
- I-84 will be repayed this summer, from I-5 to I-205, and there will be weekend lane closures one direction at a time:
  - -Friday 7/12, 10 pm to Monday 7/15, 5 am—eastbound lanes closed
  - -Friday 7/19, 10 pm to Monday 7/22, 5 am—westbound lanes closed
  - -Saturday 8/3, 11 pm to Monday 8/5, 5 am—westbound lanes closed Rain could change these dates check www.i84paving.org for updates.
- A military jet lost a wheel on takeoff at PDX and caused extensive damage to the south runway. That runway will be closed for repairs for a time causing increased use of the crosswinds runway and resulting in more low-flying airplanes over Sabin. The closure dates are April 15-May 31 and August 16-September 29.
