Description of the violation*

A developer applied for and was granted permission from the Landmarks Commission to build a new duplex at 1510 NE Fremont. This property is located in the Irvington Historio District (and within the overlap between the Sabin Community Association and the Irvington Neighborhood Association). Construction of the duplex is now underway, and the developer has violated the express terms of the approval—which specified 'no field changes'—by installing windows that appear to be: (1) from a different manufacturer and model than was specified on the approved drawing, (2) made of a different material, likely vinyl, traiter than the clad wood specified on the approved drawing; (3) with much narrower window rais than the approved drawing; and (4) installed with the plane of the lower sash recessed much less from the exterior wall than was specified on the approved drawing. In short, the developer appears to have engaged in a bait-and-switch with the City and neighbors by promising a high-quality wood window with proportions and installation compatible with the surrounding historic district in order to gain permission to build the duplex, and then later substituting a cheaper product with noticeably different proportions and installation. The Sabin Community Association's Land Use & Transportation Committee protests this blatant disregard for the considerable resources, time, and energy that the neighborhood associations and City staff invest in land use requests and historic review. The violations of the approval conditions should be corrected immediately, before the construction progresses any further and they become more expensive to oure.
