- The EAST side of NE 15th Ave 200ft NORTH of NE Skidmore St
- The EAST side of NE Prescott Ave 50ft at NE 14th Ave

- BOTH sides of NE 15th Ave 200ft EAST and WEST of NE Prescott St
- BOTH sides of NE Prescott St 200ft EAST and WEST of NE 15th Ave
